Registrar's Report

Registrations were capped to 40 skaters per division for the 2020-2021 season, resulting in a total of 460 HL registrations

2020-21 House League Report Initiation, Junior and Senior Programs

☐ Ran a program within the limitations of all the various governing bodies (Ontario Government, OMHA, Hamilton Public Health, City of Hamilton) ☐ Limited to groups of 10 with max 25 skaters on ice including coaches Near sell-out ☐ We were only allowed to run skills development to start, no games ■ Managed to run two weekends of games before lockdown ■ Season paused Nov 18 ☐ Kept going with the hopes of starting the season back up □ Ran out of time so decision made to cancel the season Feb 18

2021 Spring Skills Program

- ☐ House league program officially ended Feb 18, last time on the ice was Nov 18
- Lockdown rules relaxed at the end of Feb
- ☐ Ran a 5 week program, \$50/player, run by volunteer coaches, started Feb 26
- ☐ Sold out. 11 groups of 10 kids = 110 kids
- General feedback that people were happy to be on the ice



Bombers Rep Hockey Report



- Unique season
- ☐ Coaches were selected just prior to first lockdown
- □ No tryouts were held for 2020-2021 season all players went back to the same team they played for during the previous season.
- ☐ The season was made up of mostly development with 10 players on the ice for each session.
- □ Intersquad games were planned but only managed to get 1 game in for each age group prior to forced cancellation due to another COVID lockdown.





Bombers Rep Hockey Pilot Agreement Update



- □ Petitioned the OMHA to extend the pilot for another year due to the lack of 2020-2021 season extension granted for the 2021-2022 season.
- □ Will be looking to hold amalgamation of rep program vote in November-December 2021.
 - ☐ Will not affect House League program, it will continue to operate as it always has.
- ☐ Further information will be provided to the membership prior to the vote
 - ☐ Town hall meetings to be held to discuss and answer questions.
- ☐ Combining the rep program will help to increase competition at those levels but will not impact those that wish to remain in house league.





Development Report

- □ 2020/2021 season was entirely development run by coaches.
- □ 2021/2022 season hope to get back to outside development for House League players and goalies.
- □ Body Contact Clinics will need to occur for U13 and U14 for Bombers program





Equipment Report

- □ In 2020/2021 we provided Pro Hockey Life free skate sharpening cards to ALL players in all divisions of the AMHL and Bombers programs, currently working on sponsorship agreements for this year to provide the same.
 - This may also exclusive shopping weeks for the AMHL membership where they received additional discount on items
- □ The AMHL continued to partner with Breakaway Distributing as the main provider for all House League & IP program needs for the 2020/2021 season, currently looking at sponsorship/equipment partnerships for the upcoming year.
- □ We continue to work with major sponsors who provide support
 - McDonalds AtoMc
 - Tim Horton's IP, Novice
- □ We applied and received the OMHA.CCM goalies assist program which provided with one full set of CCM goalie equipment for our HL program.





Director of Sponsorship Report

- □ With the pandemic the sponsorship program shifted from its traditional tiered format to focus on community development through the Ancaster Minor Hockey Goodwill campaign
- □ The campaign raised close to \$1000 in funds in support of the Ancaster Community Services and in particular Ancaster Food Bank to assist the local community during these challenging times
- ☐ The program was sponsored by community partners including DCA Controls and Boston Pizza Ancaster
- ☐ With a return to the ice in the fall anticipated, it is anticipated that a program similar to the tiered structure operate in the past will return as well.



Secretary's Report

- ☐ Board followed procedures for meetings in form and substance.
- ☐ The meeting originally scheduled for May 25, 2021 was cancelled due to lack of agenda items, no meeting was held for month of May and a note to file was generated and is posted on the website. The June meeting was held earlier in the accommodate for the cancelled May meeting.
- ☐ All approved minutes are posted on the website for membership viewing.





Treasurers 2020/2021 Report

- □ Ancaster Minor Hockey is in a very healthy financial state
- □ House League Revenue was down 68.5% over last season to \$101,245

COVID restrictions on team bubble size

Increase in reserves to \$163,753 (increase of \$1,614)
